OUT OF ZONE SCHOOL BUS TRANSPORTATION REQUEST

Where school bus routes have been established and there is available space on a bus, students who are not eligible for school bus transportation based on zoning, may apply for special permission to ride the bus.

Application Process:

1. Parent/Guardian must have written approval from Student Services to attend/continue attending the school they are requesting busing for.
2. Parent/Guardian must fill in this request form and submit to school principal or designate at school of attendance.
3. School principal or designate must receive and support the request and submit to Transportation Services.
4. Transportation Services will review request and provide copy back to parent and school with approval or denial of bus service.
5. If school bus transportation is approved, Transportation Services will contact the bus driver with student information.

Please Consider:

- Students receiving approval must access the bus at an existing bus stop location. **No bus route deviation or extra expense will be authorized.**
- Permission to ride the bus may be withdrawn at ANY time if the seat is required by an eligible rider or bus routes are realigned.
- Requests will not be considered Aug 15- Sept 15 of each school year due to the high volume of requests received.
- Requests can take up to two weeks to be reviewed by Transportation Services and are considered on a first come first serve basis.
